



## **Terms and Conditions**

## **Definitions:**


- **Quiz** refers to The Wize Whispers Quiz, a financial literacy initiative organized by YES SECURITIES for educational purposes
- **Quiz Period** shall mean the period from 12:00 a.m. on 14th November 2024 until 11:59 p.m. on 31st December 2024 (IST). Entries after the Quiz Period will not be accepted
- Participant / You refers to individuals under the age of 16 years who participate in the Quiz
- YES SECURITIES shall mean YES SECURITIES (India) Limited
- **Prize** refers to the rewards given to eligible Participants based on Quiz performance, as outlined in the Prizes section
- Submission refers to the Quiz responses provided by the Participant during the Quiz Period
- Winner refers to Participants who are selected based on accuracy, time taken, and other criteria as determined solely by YES SECURITIES

After completing the quiz, participants will receive a certificate via email based on the percentage they achieved. They will also have the option to download the certificate at this time.
- **5. Scoring and Selection of Winners:** Winners will be determined based on the accuracy of answers, the Participant's first attempt, and time taken. In case of a tie, time taken will serve as the tiebreaker. All decisions made by YES SECURITIES are final.
