Team Jawaharlal Nehru School, Bhopal, represented by Kabir Dubey and Maanas Vishwakarma, secured the first runner-ups position. The competition also witnessed a thrilling tiebreaker between the second- and third-placed teams, from Team IIT Guwahati with Yash Dev Singh and Divyam Kulshreshtha finishing as the second runner-ups.

The season concluded with six winners three from the online format and three from the offline format further reinforcing the growing interest in structured financial learning at the school level.
